IT IS THEREFORE ORDERED that:


1. Post-hearing requests for information, if any, shall be filed on or before February 3, 2025.

4. Counsel for each party shall file a response memorandum addressing the issues in the initial briefs, should it so choose, on or before February 28, 2025.


5. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Standard Time, March 1, 2025.



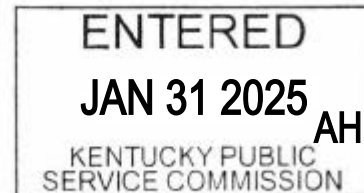
