ORDER

On August 19, 2024, the Commission issued an Order in this matter approving Columbia Gas of Kentucky's (Columbia Kentucky) Gas Cost Adjustment (GCA) rates for billing with the final meter readings beginning on and after August 28, 2024. The final Order contained two clerical errors that should be amended. Although the Commission finds it appropriate to correct these two clerical errors, it notes that the clerical errors had no impact on the final GCA rate as approved by the Commission for billing with the final meter readings beginning on and after August 28, 2024.

Finding that the August 19, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The following is stricken from page 2 of the final Order:

Columbia Kentucky's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$0.2187) per Mcf. Columbia Kentucky's total ACA is (\$1.1552) per Mcf, which is an increase of \$0.3619 per Mcf from its previous total ACA of (\$1.5171) per Mcf.

And replaced with the following language:

Columbia Kentucky's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$0.2511) per Mcf. Columbia Kentucky's total ACA is (\$1.1552) per Mcf, which is an increase of \$0.3619 per Mcf from its previous total ACA of (\$1.5171) per Mcf.

2. The following is stricken from page 2 of the final Order:

> Columbia Kentucky's report sets out a Balancing Adjustment (BA) of (\$0.04201) per Mcf, which is a decrease of (\$1.8083) per Mcf from its previous BA of 1.3882 per Mcf.

And replaced with the following language:

Columbia Kentucky's report sets out a Balancing Adjustment (BA) of (\$0.4201) per Mcf, which is a decrease of (\$1.8083) per Mcf from its previous BA of 1.3882 per Mcf.

3. All other provisions of the Commission's August 19, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
