Clover Creek Solar Project, LLC d/b/a New Frontiers Solar Park, (Clover Creek Solar), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on April 1, 2025. The Siting Board directs Clover Creek Solar to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the

information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Clover Creek Solar shall make timely amendment to any prior response if Clover Creek Solar obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Clover Creek Solar fails or refuses to furnish all or part of the requested information, Clover Creek Solar shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Clover Creek Solar shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide information on the specifications, model number, and cutsheets of the photovoltaic (PV) cell/solar panels to be used.

2. Provide any geotechnical reports that have not been provided to the Siting Board through a filing in this matter, including the updated Phase 3 of the KARST assessment.

3. Provide any data from other solar projects that EDP Renewables have gathered, utilized, and relied upon that indicates the number of local workers that have been hired in those projects.

4. Provide a copy of all environmental surveys that have not yet been provided, including the Planning and Consultation (IPAC) report.

5. Provide the executed purchase power agreement (PPA).

6. Provide a map that identifies which segments of the medium voltage collection system that are underground, which segments are above ground and the location of the transmission lines with the right-of-way distinguished.

7. Describe the location of the gas wells below ground and include whether the gas wells are within the footprint of the project. Confirm whether the following gas wells, individually, are abandoned or producing.

8. Provide a table with the distances from the nearest non-participating residence (dwelling not property line) to the following:
