
ORDER


On December 16, 2024, Commission Staff issued Commission Staff's Third Request for Information to Atmos Energy Corporation (Staff's Third Request to Atmos), which contained a typographical error stating that Atmos's response is due on December 6, 2024, whereas the response is actually due on January 3, 2025, pursuant to a procedural schedule entered on October 17, 2024.

Finding that Staff's Third Request to Atmos should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that "December 6, 2024" on the first page of Staff's Third Request to Atmos is stricken and is replaced with "January 3, 2025."
