COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO KENTUCKY POWER COMPANY

Kentucky Power Company (Kentucky Power), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on January 23, 2025. The Commission directs Kentucky Power to the Commission's July 22, 2021, Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kentucky Power shall make timely amendment to any prior response if Kentucky Power obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Kentucky Power fails or refuses to furnish all or part of the requested information, Kentucky Power shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Kentucky Power shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Kentucky Power's Tariff P.P.A. Tariff Filing, tendered September 3, 2024. Provide sample bills and narratively describe the effects of:
 - a. The proposed rates, placed into effect subject to refund, on and after September 28, 2024; and
 - b. The current Commission approved rates, in effect for the period immediately preceding September 28, 2024.

2. Refer to Kentucky Power's Annual Updated Filing, Excel file, tendered September 3, 2024. Confirm that the use of forecasted billing determinants, as calculated in the response, reduces the under-recovery of the rider mechanism. If not confirmed, explain why.

3. Provide the under-recovery or over-recovery of the Tariff P.P.A., as of the date of service of this request.

4. Confirm that Kentucky Power intends to securitize, pursuant to Case No. 2023-00159,² the entirety of the amount provided in response to Item 3. If not confirmed, explain.

5. Confirm that the proposed Tariff P.P.A. rates reflect the calculation of the Rockport True-Up as approved on December 20, 2024, in Case No. 2024-00016.³ If not, provide an updated calculation and rates.
