ORDER

On October 9, 2024, Kentucky Municipal Energy Agency (Kentucky Municipal Energy) submitted a \$85,200 application fee, as required by KRS 278.706(5) and 807 KAR 5:100, Section 5. The fee was acknowledged by letter from the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board) dated October 9, 2024. On April 2, 2025, the Siting Board issued an Order granting a Conditional Certificate of Construction to Kentucky Municipal Energy. As of July 1, 2025, the Siting Board had accrued \$117,394.16 in case-related expenses, for a shortfall of \$32,194.16 as of that date. KRS 278.706(5) provides, “If a majority of the members of the board find that an applicant's initial fees are insufficient to pay the board's expenses associated with the application, including the board's expenses associated with legal review thereof, the board shall assess a supplemental application fee to cover the additional expenses.” The Siting Board, therefore, finds that Kentucky Municipal Energy should pay an additional

amount totaling \$32,194.16 as a supplemental application fee for expenses already incurred.
