<u>ORDER</u>

On January 18, 2025, Kentucky Industrial Utility Customers, Inc. (KIUC) filed a motion for leave to file brief out-of-time,¹ along with its brief.² Pursuant to the procedural schedule filed on December 20, 2024,³ briefs were due on January 17, 2025. In support of its motion, KIUC explained that unforeseen technological issues prevented the timely filing of its brief, which was due on January 17, 2025, as set forth in the procedural schedule.⁴ KIUC submitted the brief one day late and contended that the delay was unanticipated and unlikely to prejudice any parties.⁵

On January 20, 2025, Kentucky Power Company (Kentucky Power) submitted notice indicating that it would not be filing a response brief and did not oppose KIUC's motion.⁶
