
ORDER


On February 11, 2025, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, Metropolitan Housing Coalition, and Mountain Association (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Gilbert Zelaya, an attorney whose office is in New York, to practice law before the Commission on behalf of the Joint Intervenors in association with Byron L.
