ORDER

On May 19, Wood Duck Solar LLC (Wood Duck Solar) filed an application seeking a Construction Certificate, pursuant to KRS 278.700, to construct an approximately 100-megawatt merchant electric solar facility and nonregulated transmission line in Barren County, Kentucky. On June 16, 2025, the Siting Board filed an Order scheduling a local public hearing for July 1, 2025, at 5 p.m. Central Daylight Time at the Barren County Fiscal Courthouse.

The Siting Board, on its own motion, finds that the July 1, 2025, local public hearing in this matter should be canceled and rescheduled to facilitate participation for local residents and officials. Accordingly, the Siting Board finds that a local public hearing should be scheduled on July 15, 2025, at 5 p.m. Central Daylight Time, at the Barren County Fiscal Courthouse, at 117 N. Public Square, Suite 3A, Glasgow, KY 42141.

Siting Board regulation 807 KAR 5:110, Section 8(3)(b), requires that the Siting Board provide notice of the local public hearing to the Barren County Judge Executive and the Joint City-County Planning Commission of Barren County. The Siting Board finds

that a copy of this Order should be served upon Barren County Judge Executive Jamie Byrd and the Joint City-County Planning Commission Chair Tommy Gumm.

IT IS THEREFORE ORDERED that:

- 1. The local public hearing previously scheduled in this matter is canceled and rescheduled for July 15, 2025, at 5 p.m. Central Daylight Time, at 117 N. Public Square, Suite 3A, Glasgow, KY 42141.
- 2. Portions of the June 16, 2025 Order in conflict with this Order shall no longer be effective. The remainder of the June 16, 2025 Order shall remain in effect.
- 3. A copy of this Order shall be served upon the Barren County Judge Executive and the Chair of the Joint City-County Planning Commission.
- 4. Wood Duck Solar shall give timely notice of this local public hearing in a newspaper of general circulation in Barren County as required by 807 KAR 5:110, Section 9(2).
- 5. Wood Duck Solar shall submit proof to the Siting Board of the notice to the public at least three days prior to the July 15, 2025 hearing.
