## ORDER

The Commission, on its own motion, HEREBY ORDERS that:

- A hearing in this matter shall be held on April 17, 2025, beginning at 9 a.m.

- 2. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
- 3. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at the April 17, 2025 hearing except as set out below.
- 4. Pursuant to the Order issued January 9, 2025, Richard Baudino shall appear virtually. Commission Staff should arrange a technological test at least three days prior to the hearing with the Attorney General's Office and Mr. Baudino.

- 5. All parties shall file a witness list at least seven days prior to the hearing date.
- 6. Delta Natural Gas Company, Inc. (Delta) shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, Delta shall forward a duplicate of the notice and request to the Commission.
- 7. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
