ORDER

IT IS THEREFORE ORDERED that:




2. No evidence shall be taken at the local public hearing.
3. Recordings of the in person public comment meeting will be filed into the record of this case.
4. Delta shall provide written notice of the time and place of the local public hearing pursuant to 807 KAR 5:001, Section 9(2).
5. Within 20 days after publication, Delta shall file proof of publication in the file.
6. Delta shall ensure that a representative(s) is present at the public meetings.
