ORDER

On March 21, 2025, Shelby Energy Cooperative, Inc. (Shelby Energy) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) (jointly, the parties) filed a joint motion to waive a formal hearing on this matter and submit simultaneous briefs regarding the issues in this proceeding. The parties jointly requested the Commission allow the parties to file simultaneous briefs on May 2, 2025, and then permit the matter to be submitted on the record after the briefs are filed without the need for a formal hearing.

Based on the motion and being otherwise sufficiently advised, the Commission finds that Shelby Energy and the Attorney General have established good cause to grant their joint motion to waive formal hearing, submit the case on the record and establish a schedule for simultaneous briefing the parties' respective positions on the issues presented in this proceeding.

IT IS THEREFORE ORDERED that:

1. Shelby Energy and the Attorney General's joint motion waiving formal hearing and submit the case on the record is granted.

2. Shelby Energy and the Attorney General's joint motion to file simultaneous briefs is granted.

3. Shelby Energy and the Attorney General shall file simultaneous initial briefs on or before May 2, 2025.

4. Shelby Energy and the Attorney General, if they so choose, may file response briefs addressing only issues raised in the initial briefs on or before May 9, 2025.

5. The case shall stand submitted for a decision by the Commission effective at 12:01 a.m. on May 10, 2025.
