ORDER

On November 25, 2024, East Kentucky Power Cooperative, Inc. (EKPC) filed an application for a certificate of public convenience and necessity (CPCN) to construct new generation resources, a site compatibility certificate relating to the same, approval of demand side management (DSM) tariffs, and other general relief.¹ The Commission established a procedural schedule by Order dated December 5, 2024, that, among other things, set a date for a public hearing.

Due to numerous scheduling conflicts, the Commission, on its own motion, finds that the procedural schedule established on December 5, 2024, should be amended to ensure witnesses and Commission Staff availability for the hearing.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on December 5, 2024, is amended.

¹ Application was tendered on November 20, 2024, but was found deficient by the Commission. Deficiencies were subsequently cured by letter dated November 25, 2024.

2. A hearing in this matter shall be held on April 21–23, 2025, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

3. The procedural schedule set forth in the Appendix to this Order shall be followed.
