<u>O R D E R</u>

On November 20, 2024, Bluegrass Gas Sales, Inc. (Bluegrass) filed its proposed

Gas Cost Recovery (GCR) rate report to be effective January 1, 2025. Bluegrass's

previous GCR rate was approved in Case No. 2024-00274.¹

LEGAL STANDARD

The Commission's standard of review for GCR rates is well settled as stated in

KRS 278.274(1):

In determining whether proposed natural gas utility rates are just and reasonable, the commission shall review the utility's gas purchasing practices. The commission may disallow any costs or rates which are deemed to result from imprudent purchasing practices on the part of the utility.

Further, the utility has the burden to prove the rates are just and reasonable and

the Commission may reduce the purchased gas component of the utility's rates or the

rates charged by an affiliated company to the extent the amount is deemed to be unjust

or unreasonable.²

DISCUSSION

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that Bluegrass's report includes revised rates designed to pass on to its customers an expected change in gas costs. Bluegrass's report sets out an Expected Gas Cost (EGC) of \$5.2901 per Mcf, which is an increase of \$0.1003 per Mcf from its previous EGC of \$5.1898 per Mcf. Bluegrass's report sets out no Refund Adjustment. Bluegrass's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$0.0150) per Mcf. Bluegrass's total ACA is \$0.9855 per Mcf, which is an increase of \$0.0092 per Mcf from its previous total ACA of \$0.9763 per Mcf. Bluegrass's report sets out a current quarter Balance Adjustment (BA) of \$0.0107 per Mcf. Bluegrass's total BA is (\$0.1231) per Mcf, which is a decrease of \$0.0055 per Mcf from its previous total BA of (\$0.1176) per Mcf.

Based on the calculations above, the Commission finds that Bluegrass's GCR rate is \$6.1525 per Mcf, which is an increase of \$0.1040 per Mcf from its previous GCR rate of \$6.0485 per Mcf. The Commission further finds that the rates set forth in the Appendix to this Order are fair, just and reasonable and should be approved for service rendered by Bluegrass on and after January 1, 2025.

For the purpose of transparency and to maintain a record of information for future use, the Commission finds that Bluegrass should submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. Should Bluegrass purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Bluegrass and set forth in the Appendix to this Order are approved for service rendered on and after January 1, 2025.

2. Bluegrass shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports.

3. Should Bluegrass purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount shall be documented in its cover letter to the Commission.

4. Within 20 days of the date of service of this Order, Bluegrass shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

5. This case is closed and removed from the Commission's docket.
