ORDER

IT IS THEREFORE ORDERED that:

1. An in-person informal technical conference shall be held on February 26, 2025, at 1 p.m. Eastern Standard Time at the Commission’s offices at 211 Sower Boulevard, Frankfort, Kentucky, to allow South Kentucky RECC to provide a technical presentation on the financial schedules included with the application.


2. Commission Staff will contact participants by electronic mail to provide details for intervenors and other non-presenting individuals to remotely attend the conference by video link.
