ORDER

On February 3, 2025, South Kentucky Rural Electric Cooperative Corporation (South Kentucky RECC) filed an application with the Commission, pursuant to KRS 278.180, KRS 278.190, and 807 KAR 5:001, requesting a general adjustment to its rates. On February 19, 2025, the Commission entered an order suspending South Kentucky RECC's proposed rates for five months and established a procedural schedule.¹ On March 27, 2025, South Kentucky RECC filed a motion to amend procedural schedule. In its motion, South Kentucky RECC requested a two-week extension to file its response to the Attorney General's First Request for Information (First Request).² South Kentucky RECC stated that the Attorney General's First Request contained 350 requests, including subparts.³ South Kentucky RECC also stated that it only has one employee who has the ability to compile the data required to respond to the

requests⁴ and that many of the requests require South Kentucky RECC to review years of data to respond to the requests.⁵

Having reviewed the record and being otherwise sufficiently advised, the Commission, finds that South Kentucky RECC's motion to amend procedural schedule should be granted. The Commission further finds that the procedural schedule established on February 19, 2025, should be amended to afford South Kentucky RECC additional time to respond to the Attorney General's First Request.

IT IS THEREFORE ORDERED that:

1. South Kentucky RECC's motion to amend procedural schedule is granted.
2. The procedural schedule established on February 19, 2025, is amended.
3. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
4. All provisions of the Commission's February 19, 2025 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
