BEFORE 2019 (OLD MANAGEMENT) 🔊

1. MCWD had never applied for a rate case through the PSC from 1992 to 2015 (23 years). Since 2019, we have been ordered by the PSC to conduct a rate study every three to five years. PSC Rate Cases: 2016, 2021, 2024.

a. In the 2016 Rate Case, the PSC recommended a 26.56% increase, stating the District needed this rate to meet its financial obligations. The District initially refused to accept that rate and only wanted a 15% increase. In 2017, the District acknowledged its error and requested the full 26.56% recommended rate. This action resulted in continued lack of confidence and growing concerns from the PSC about the District, as stated in later cases and orders.

2. In 2019, MCWD was called to a formal hearing by the PSC. The investigation uncovered gross mismanagement of financial practices, no rate review schedule, and lack of system compliance by the management. By 2019, MCWD was not meeting its basic responsibilities in finance, water quality audits, PSC audits, and water system management. It was on the path to a complete system failure on all fronts. KRWA and KYDOW had already begun working on contingency plans for MCWD's failure, stating, "It's not a matter of if, but how quickly it will fail."

3. Water loss during this period was approaching 70%. Four active leaks known to field staff were not fixed until the new management addressed them in December 2019.

4. The District was not able to make bond payments, being over 30 days late with 90% of vendors. In spring of 2019, the board had to borrow \$30,000.00 to cover a debt service payment due in July 2019.

5. No asset management program, no GIS mapping program, and approximately 60% of assets such as valves, hydrants, blow-offs, air relief valves, and meters were not identified or located. There were no preventive maintenance plans in place.

6. No inventory management program in place.

7. No Capital Improvement Plan in place.

8. No Rate Structure Review Plan in place.

9. No collection plan for bad debt; approximately \$70,000 of unpaid water bills by the end of 2019.

10. MCWD owed the City of West Liberty approximately \$35,000.00 in old water bills over many years.

11. Computers, SCADA, and office equipment were outdated and/or not working properly.

12. No safety equipment was available, and there was non-compliance with OSHA regulations regarding trenching, traffic, chlorine, confined spaces, fall protection, and MSDS stations.

13. A lack of proper system-wide water sampling. Most samples were repeatedly taken from the same locations. Samples should be pulled to represent the entire water system.

14. The 2016 AML water project began with \$730,000 in grant funds to MCWD – by 2020, no assets from that project were in use. Over 8,000 feet of 6-inch line and a \$250,000 pump station with a \$30,000 generator were never turned on or used.

15. No updated reviews of policies and procedures in place. Employment policies had not been updated since 1999.

16. Only one Class 2 Operator was on staff (KYDOW requires at least one Class 2 Operator for our system), with no backup operator.

17. Inaccurate financial reporting due to a lack of basic accounting training and experience.

18. Over 2,200 meters had not been tested within the ten-year regulation by PSC—no plan in place to address this issue from 2006 to 2009.

19. Multiple violations with KYDOW in water quality compliance.

20. No credit card machine, no online payment options for customers.

THE CHANGE AFTER 2019 (NEW MANAGEMENT)

1. A complete update and review of all policies, employee handbook, utility tariff, O&M manual, and other procedures. We now conduct a yearly review of all policies.

2. Asset management program – we implemented an ARC/GIS mapping system with KRWA and Gateway AD through an ARC grant. By 2024, 99% of all assets have been GPS located to within a foot. We hired a Field Maintenance Supervisor to develop and implement a preventive maintenance plan that includes monthly asset inspection and maintenance.

3. The 2021 rate increase funded essential equipment purchases and additional hires.

4. In 2020, credit card and online payments were implemented. This reduced office staff time in processing payments by approximately 25%.

5. By the end of 2024, MCWD will have a new cloud-based billing system, offering customers the option of paperless billing and the ability to make payments over the weekend.

6. A bad debt collection plan was implemented in 2020; to date, over 400 accounts have been turned over to collections, totaling \$60,646.24, with \$11,499.60 collected.

7. A system-wide flushing program began in 2021 with 192 flush hydrants and 228 blow-offs. This is a regulation

8. A valve exercise program started in 2021, covering 1,625 gate valves. This is a regulation

9. We hired a dedicated Leak Detector and purchased leak detection equipment in the summer of 2020.

10. Water loss was reduced to 34% by the end of 2023.

11. In the summer of 2023, the PSC removed the \$5.87 surcharge from customer bills for water loss due to successful water loss reduction efforts.

12. In 2022, MCWD was nominated as a Top 10 Water Utility in the State of Kentucky by KRWA.

13. In 2023, MCWD was awarded the KRWA Wooden Bucket Award as the #1 rated Water Utility in the state of Kentucky.

14. Since 2020, all bond payments have been made on time, with approximately 90% of vendors paid within 30 days.

15. The City of West Liberty's water bill was paid in full in 2021, with all subsequent bills paid on time.

16. MCWD now has (one) Class 3 operator, (one) Class 2 operator, and (two) Class 1 operators, with three more employees set to test in 2024.

17. Auto flushing has been reduced from over 4 million gallons to just over 400,000 gallons a month, saving the district over \$100,000 a year.

18. An Inventory Management System is in place, with two inventory audits conducted annually.

19. A Rate Structure Review plan is now in place, reviewed yearly, with a Rate Study conducted every three to five years.

20. A Capital Improvement Plan is in place, with two projects completed since 2019. MCWD has secured over \$5 million in grants for projects, with another \$10 million applied for in 2024 and 2025. We have four future project profiles approved by the regional water council.

21. MCWD has identified 84 sample sites in our system, and these sites have been GPS located. Our operators are pulling water samples from a broader range to ensure all our customers receive the best quality water possible.

22. A new Finance/Purchasing officer was hired, and we have completely overhauled our accounting system, leading to more accurate financial reports.

23. We are setting up a partnership with Toyota Manufacturing in Georgetown to help reduce waste (cost) in our system and implement a "LEAN WATER MANAGEMENT SYSTEM" mirrored from the Toyota Production System.
