
MOTION TO RESCHEDULE HEARING

This matter was originally established by an Order of the Commission, dated March 4, 2024. The hearing in this matter was set for April 26, 2024, by an Order of the Commission, dated March 4, 2024. On March 29, 2024, Staff received notice of Fast Flow Plumbing, LLC Chapter 11 filing in United States Bankruptcy Court, Eastern District of Kentucky, Lexington Division, Case Number 24-20346. This filing initiates an automatic stay pursuant to 11 U.S.C. 362(a)(1), which states “the commencement or continuation, including the issuance or employment of process, of a judicial, administrative, or other action or proceeding against the debtor that was or could have been commenced before the commencement of the case under this title, or to recover a claim against the debtor that arose before the commencement of the case under this title.” Staff is requesting that the hearing currently set for April 26, 2024, be cancelled. Staff asks that the hearing be held on October 25, 2024 in order to accommodate the automatic stay and determine if the reorganization under Chapter 11 has been resolved by that time.

WHEREFORE, Staff respectfully requests that the above titled case, originally set for April 26, 2024, be cancelled and a new hearing set for October 25, 2024, at 9 a.m.

ORDER

On April 04, 2024, Division of Inspections Staff (Staff) filed a motion to cancel the hearing set for April 26, 2024, and requested the hearing be held October 25, 2024. On March 29, 2024, Staff received notice of Fast Flow Plumbing, LLC's Chapter 11 filing in United States Bankruptcy Court, Eastern District of Kentucky, Lexington, Division, Case Number 24-20346. This filing initiates an automatic stay pursuant to 11 U.S.C. 362(a)(1), which states "the commencement or continuation, including the issuance or employment of process, of a judicial, administrative, or other action or proceeding against the debtor that was or could have been commenced before the commencement of the case under this title, or to recover a claim against the debtor that arose before the commencement of the case under this title." Staff requested the date be rescheduled to October 25, 2024, at 9 a.m. Eastern Daylight Time in order to accommodate the automatic stay and determine if the reorganization under Chapter 11 has been resolved by that time.

Having considered the motion, the Commission finds that the formal hearing in this matter set for April 26, 2024 should be cancelled, and a new hearing date set for October 25, 2024 at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room of the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky, for the purpose of

presenting evidence concerning the alleged violation of the Underground Facility Damage Prevention Act.

IT IS HEREBY ORDERED that:

1. The hearing scheduled for April 26, 2024 is cancelled.

2. Fast Flow Plumbing, LLC shall appear on October 25, 2024, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violation of the Underground Facility Damage Prevention Act.

3. The October 25, 2024 hearing shall be conducted via video conferencing.

4. Fast Flow Plumbing shall attend the hearing by using the following link: <https://meet.goto.com/pscformalhearing/psc-damage-prevention-hearing>; information and instructions are attached to this Order as Appendix B.

5. Fast Flow Plumbing, LLC shall notify the Commission at least ten days prior to the hearing if Fast Flow Plumbing, LLC is unable to appear by video conferencing and will therefore appear in person.

6. **Any partnership, corporation, or business entity (including a limited liability company) must be represented by an attorney licensed to practice law in Kentucky, and such representation includes the filing of papers with and appearances at hearings before the Commission.**

7. An individual may submit a response to the allegations contained in the Staff Incident Report without the representation of an attorney.

8. The Staff Incident Report 54638, attached to this Order as Appendix A, is made a part of the record in this case.

9. The October 25, 2024 hearing shall be recorded by video only.

10. **Please note parties who fail to appear after service will be subject to entry of a default judgment against them.**
