RE: Informal Conference of August 27, 2024

Pursuant to an Order issued on August 16, 2024, an in-person informal conference (IC) was conducted on August 27, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to allow East Kentucky Power Cooperative, Inc. (EKPC) an opportunity to review its future goals and objectives, to discuss its proposed settlement regarding the related federal litigation, and to cover issues on the pending tariff. This IC was scheduled at the request of EKPC in its motion filed on August 14, 2024. Representatives of EKPC presented issues regarding the current tariff, such as expected upcoming filings and its basis for proposing generation to address an upcoming capacity shortage, RICE units. Staff engaged in discussions with EKPC representatives on issues brought forth and advised that the issues would have to be presented to the Commission for final determination as Staff cannot speak for the Commission. No information or documents were requested by Commission Staff during the IC.

There being no further discussion, the IC was then adjourned.
