The email below from Travis Spiceland siting the 1978 Title 807 Chapter 005 Regulation 054 of the Kentucky Administrative Regulations (KAR) I believed has been superseded by the current PSC Net Metering requirements updated and approved in Feb 2014 and the May 14, 2021 PSC Press release. I am needing assistance in answering WHY JPEC will not allow an interconnection agreement to be established for a leased solar system with the option to fully own. I have read all the attached material and still

have no clarification. I feel I should be at least to establish an agreement under the Net Metering Tier 2 Tariff to establish a connection for a system that is under 30KW. Any production in excess power would be sent back to JPEC at the wholesale rate. And I was called directly by JPEC and spoke with Conner and he tried to talk us out of a Solar system.
