- 3. <u>807 KAR 5:076 Section 4(1)(c):</u> Copy of amortization schedule for each outstanding bond issuance, promissory note, and debt instrument; Copy of amortization schedule provided for only one out of seven bonds.
- 4. <u>807 KAR 5:076 Section 4(1)(d):</u> Depreciation Schedule for all utility plant in service; Incorrect test year used.
- 5. <u>807 KAR 5:076 Section 4(1)(f):</u> Detailed Analysis of Applicant's customers' bills showing revenues from present and proposed rates from each customer class (Attachment BA-DB or Attachment BA-FR is attached to ARF Form-1); Incorrect test year used.
- 6. <u>807 KAR 5:076 Section 4(1)(a):</u> A completed Attachment SAO (Statement of Adjusted Operations) is attached; Incomplete SAO due to use of incorrect test year.
- 7. <u>807 KAR 5:076 Section 4(1)(a):</u> A completed Revenue Requirement Calculation Form (Attachment RR-DC or Attachment RR-OR) is attached to ARF Form-1; Incomplete Revenue Requirement Calculation form due to use of incorrect test year.
