The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.


Filing deficiencies pursuant to:

1. 807 KAR 5:001 Section 8 (4) (b) (2): Each file in an electronic submission shall be search-capable.
2. 807 KAR 5:076 Section 5 (4) (c): The amount of the change requested in both dollar amounts and percentage change for each customer classification to which the proposed rates will apply; The decimals are not consistent. The per Ccf rates need to be displayed at least three decimal places out to reflect the full rate (both for the Clinton County and the Floyd/Johnson County notices); The percentage change in rates should be double checked to ensure no rounding errors or general errors (i.e., the percentage increase from \$99 to \$124 is not 457%); In Attachment 1 to Application Page 9 of 9, the bill impact for Agricultural should not be zero across the board by virtue of the existence of the customer charge. Additionally, an estimated average monthly usage can be used even in cases where no customers are present.
3. 807 KAR 5:076 Section 4 (1) (a): A completed Attachment SAO (Statement of Adjusted Operations) is attached; SAO is missing from application.

You are requested to submit the information necessary to cure the deficiencies within 10 days of the date of this letter. If you need further assistance, please contact Brian Thomas at 502-564-3940.
