Pursuant to Staff Notice issued on October 22, 2024, an informal conference (IC) was conducted on October 25, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the amendment to a certificate of public convenience and necessity (CPCN). Specifically, if another amendment will be needed and alternatives to the proposal.

EKPC summarized discussions with landowners in the project area. The original landowner of the proposed switching station location no longer wanted to sell the land; however, the landowner is willing to discuss easements. The design of the switching station at the amended proposed location will have 4 69 kV transmission lines going into the station.

In response to questions from Staff, EKPC agreed to file the updated study transmission planning study as well as an update on discussion with property owners in the area.

There being no further discussion, the IC was then adjourned.
