**FARMDALE WATER DISTRICT’S WAIVER OF RIGHT TO
HEARING AND MOTION FOR DECISION ON WRITTEN RECORD**

By and through the undersigned counsel, pursuant to the Commission’s April 21, 2026 Order in this proceeding Farmdale Water District (“Farmdale District” or “the District”) submits its waiver of a right to a formal hearing and Motion for a decision upon the written record.

In support of its Motion Farmdale District states:

1. The Complaint, which is the subject of this proceeding was filed on August 16, 2024.
2. On December 27, 2024, the Commission entered an Order in this proceeding requiring Farmdale District to satisfy the matters set forth in the

Complaint or to file a written Answer to the Complaint within 10 days of the Order.

3. On January 6, 2025, Farmdale District filed its Answer into the record of this proceeding.

4. On May 16, 2025, Joy and Matthew Lee filed a Response to the District's Answer.

5. On April 21, 2026, the Commission entered an Order establishing a procedural schedule in this matter.

6. On April 30, 2026, Joy and Matthew Lee filed a statement into this proceeding providing "At this time, we have no additional evidence to submit and no further statements to provide."¹

7. On May 5, 2026, Commission Staff propounded its First Requests for Information to the District and to Joy and Matthew Lee. The Responses were due on May 21, 2026.

8. On May 12, 2026 Farmdale district filed its Response to Staff's First Request for Information.

9. Joy and Matthew Lee have not filed a Response to Staff's First Request for Information.

10. The procedural schedule issued by the Commission on April 21, 2026, established May 28, 2026 as the deadline to file supplemental requests for

information.

11. No additional requests for information have been issued.

12. The procedural schedule established June 17, 2026, as the deadline for parties to request a public hearing or submit a request for the matter to be decided based upon the written record.

WHEREFORE, on the basis of the foregoing, Farmdale District waives its right to a hearing in this matter and respectfully moves that the Commission enter a decision in this case based upon the written record.
