Dear Ms. Wyatt:

As the Chairman of the Kentucky Public Service Commission (PSC), I also serve as the Chairman of the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board). Therefore, it is my duty to inform you that, on September 3, 2024, the Siting Board received a Notice of Intent from Kentucky Municipal Energy Agency requesting a certificate to construct an approximately 75-megawatt merchant electric solar generation facility in Hopkins County, Kentucky.

The five permanent members of the Siting Board are the Chairman, Vice Chairman, and Commissioner of the PSC, the Secretary of the Energy and Environment Cabinet (or her designee);¹ and the Secretary of the Economic Development Cabinet (or his designee).²

In addition to the permanent members of the Siting Board, pursuant to KRS 278.702(1)(d)(1), one of the Siting Board ad hoc members is the chairman of the planning commission with jurisdiction over the area in which the facility will be located. Based on the facts as presented in the application, you will serve as one of the ad hoc Siting Board members as the Chairman of the Harrison County Planning and Zoning Commission.

Pursuant to KRS 278.710(1), the Siting Board is required to issue its decision granting or denying the application within either 120 days or 180 days, if a local public
