

ORDER

On February 11, 2025, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, Metropolitan Housing Coalition, and Mountain Association (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Cassandra McCrae, an attorney whose office is in Pennsylvania, to practice law before the Commission on behalf of Joint Intervenors in association with Byron L. Gary, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case.
