**RE:** Informal Conference (IC) of January 16, 2025

Pursuant to an Order issued on January 6, 2025, an informal technical conference (IC) was conducted on January 16, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss aspects of the application filed on December 10, 2024, pertaining to Shelby Energy Cooperative, Inc.'s (Shelby Energy) application for an increase of rates based on a historical test year pursuant to KRS 278.180 and KRS 278.190. This IC was scheduled by Order of the Commission.

Representatives of Shelby Energy and the Intervenor, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), were present. Catalyst consultant, John Wolfram, on behalf of Shelby Energy, reviewed various sections of the application, specifically focusing on attachments JW-2 through JW-9 of Exhibit 10 in the application.
