Pursuant to KRS 278.700 et seq., and 807 KAR 5:110, Lost City Renewables LLC (“Lost City”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Lost City states as follows:

1. Lost City is a limited liability company organized under the laws of Delaware on June 21, 2022, with a principal place of business of 12 W 15th Street, 15th Floor, New York, NY 10011. Lost City’s phone number is (843) 510-5254. Lost City is authorized to do business in Kentucky as of December 5, 2024.

2. The proposed Lost City Solar Facility will be up to 250-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Muhlenberg County approximately 0.4 miles east of Penrod and 1.25 miles northeast of Dunmor, at the following location: 37°06'15.45"N, 86°58'48.535"W.
