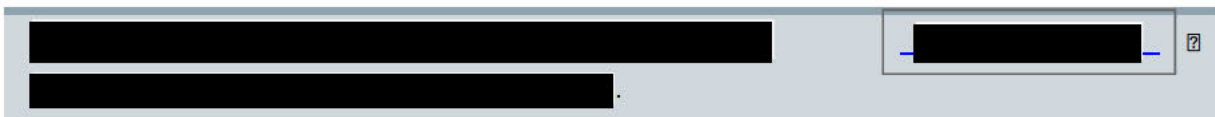

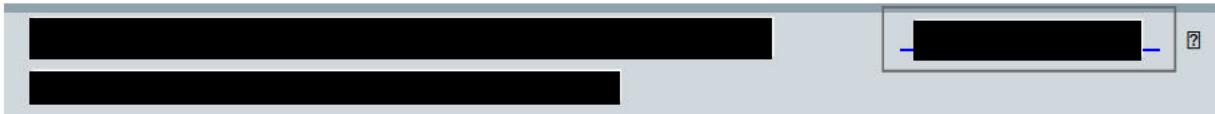

I am writing in opposition to KU's proposed rate adjustments. Based upon the notice to customers, their planned increase in total rates amounts to about \$2.2 billion and nearly \$100,000,000 for residential customers. Current residential customers number 545,000 according to their web site, which KU states is an increase of 13.55% per household. This is proposed even though the kW/h has reduced nearly 1% since 2022. There have been several conditions that may have caused the decrease, i.e., appliances and light bulb efficiency, solar energy increased production, insolation incentives, changes to gas, etc. We have solar and they give us credit for sending our excess power of \$0.07364/ kWh and sell the power to us at \$0.09699 or about 25% more. They also charge us for environmental surcharge on the total invoice. We have attempted to perform all of the efficiency items listed above, including added a solar system and this has resulted in just a reduction of our payments of less than 50%. KU has also proposed raising the residential users more than all the other users. KU should undergo a complete audit to confirm that any increase is warranted.

KU's numbers need to be verified. For example, they have indicated that the total annual

increase for their proposed residential actions would be \$99,997,335, but based on the number of residential customers, the total increase would be \$119 billion, not the \$100 billion they have reported. Also, the \$100 billion annual increase amounts to \$183.48 per household and not the \$217.80 per household as they have indicated. If any increase can be justified, other solutions should be examined.

I received a notice in my last month's Kentucky Utilities statement concerning an enormous proposed rate increase. I am retired, with the majority of my income coming from Social Security. With the present inflation rate of about 2.4%, I feel that this increase application is an extravagant request. I understand companies needing an increase to keep up with inflation, but, I feel that the 11.5% increase proposed is way too much. Unlike most commodities, I have no other company from which to shop for electricity. My last twelve month's electricity usage totaled \$2,089.66 which would be

an annual increase of \$225.91 based on the current proposed increase request. This means I would have to pay the equivalent of 13.3 months of service based on the proposed rate over the present rate. I urge you to consider limiting Kentucky Utilities rate increase to not more than 3.6% which is still 1.5% of the current inflation rate. Thank you for taking time to read and understand my response to their request.
