I understand that there will be a public hearing on October 14 to allow consumers to comment on the proposed rate increases. However, I will be out of town next week and unable to attend so I would like to submit my comments in writing.

My two concerns are:

1) KU/LGE's proposed basic service charge increase of 21% will overwhelmingly hurt low income users (low level users of electricity), and will discourage the conservation of

energy.

2) Drastically reducing credits for net metering will hurt the users of solar power and reduce the incentive to invest in solar energy. This is totally backwards in our climate situation and unacceptable.
