This email is to request that the PSC deny any rate increase request for residential electric and residential gas. LG&E's requested rate increases will kill retirees, like myself.

The document LG&E provided to the PSC is far from accurate, as far as the actual increases, and the amount that projected bills will go up by.

#1) LG&E's Residential Electric Service Charge requested increase, if approved, will go up by 15.6%.

#2) LG&E's Residential requested kilowatt hour requested increase, if approved, will go up by 9.5%.

#3) For Residential electric, the above sum rate increase will be 25.1%.

#4) LG&E's Residential Service Charge for gas, if approved, will go up by 24.6%.

#5) LG&E's Residential charge for gas per ccf, if approved, will go up by 11.6%

#6) For Residential gas, the above sum rate increase for gas will be 36.2%

#7) The requested increase for electric is 25.1%, plus the requested increase for gas, which is 36.2%, for an overall sum rate increase request of 61.3%. This increase amount is nothing but absurd, and if allowed by the PSC, will do nothing but continue to let LG&E rip off customers. LG&E already has some of the highest rates for electric and gas in the country on a per unit basis. My last bill showed I am paying 24.1 cents per kwh, and \$4.23 per ccf for gas...a ridiculously high per unit cost. The Bureau of Labor Statistics currently shows the average cost increase, per kwh, across the U.S over the last fifteen years, is 3.8%, and for gas it's 5.6%. Why are LG&E's rates and fees so high when compared across the country?

#8) I'm asking the PSC to deny all of LG&E's rate increase request.
