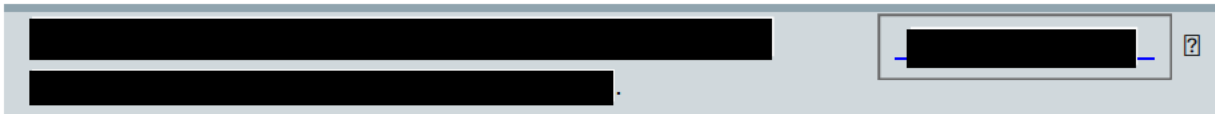

Concerning the proposed rate changes of 8.3% on electrical services and 14.0% for gas services.

As a business owner we are fighting increased costs on EVERY aspect of our business. Inventory, labor, insurance, rent etc. Currently, in 2025, we have used about 8.5% more kWh than in the same time period as we did in 2024. At the same time, our bill has increased 13.5%.

If I understand the application correctly, they are seeking an "Annual Increase". These proposed increases are substantial and extremely hurtful to every small business owner fighting to keep their doors open.

I urge the Commission to deny this application or at least to limit the amount of the increase to a much more manageable one, than the current amounts being proposed.
