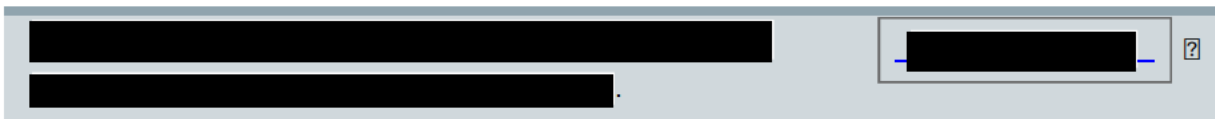

I am appalled by the suggested rate hikes, which heavily burden residential customers over commercial customers and are being proposed after we have already seen a significant increase in rates in the last few years.
