Commission, I am writing as a concerned resident of Kentucky to formally express my opposition to Duke Energy Kentucky's request to increase gas rates. This proposal, if approved, would place an undue financial burden on consumers including myself—many of whom are already struggling with the rising cost of living, inflation, and stagnant wages. Natural gas is a basic necessity for heating, cooking, and maintaining household operations. Increasing these rates, especially during economically uncertain times, would disproportionately impact low- and fixed-income households, senior citizens, and working-class families. Rate increases must be justified by clear, transparent evidence of need—not simply to boost profits or shareholder returns. At a time when utility companies should be working to support communities, especially the most vulnerable, this request feels out of touch and deeply unfair. I urge the Commission to thoroughly scrutinize Duke Energy's proposal and reject the request for a gas rate hike. The people of Kentucky deserve affordable and equitable access to essential services, not higher bills with limited accountability. Thank you for your time and attention to this matter.
