Comments: THEY USED MY HOME ADDRESS SAYING THIS IS THE SITE FOR EXIE SOLAR FARM. I HAVE LIVED AT THIS ADDRESS FOR 24 YEARS AND PLANNED ON BEING MY FOREVER HOME. I DRIVE 15 MILES TO AND FROM WORK EVERYDAY TO LIVE IN THE COUNTRY. THE VIEW FROM EVERY SIDE OF MY HOUSE IS BEAUTIFUL COUNTRY FOLLIAGE AND WILDLIFE. I ENJOY LIVING HERE. I AM NOT OPPOSED TO SOLAR BUT I BELIEVE IT SHOULD NOT TAKE UP AGRICULTURE FARMLAND. MY DAUGHTER WAS VACCINE INJURED AS A YOUNG CHILD WHICH CAUSED HER TO HAVE SEIZURES. SHE JUST WEANED OFF HER SEIZURE MEDICINE AFTER OUR FAMILY HAVE CHANGED OUR LIFESTYLE TO HELP HER HEAL. I DONT WANT EMFs AND CHEMICALS, WHICH LEECH FROM THE PANELS WHEN INSTALLED OR DAMAGED, AROUND MY FAMILY. MY FAMILY IS OUTSIDE ALL THE TIME. MY CHILDREN PLAY IN OUR YARD ON THEIR PLAYSET AND WITH OUR ANIMALS. WE TRY TO LIVE A CLEAN LIFESTYLFE. WE GROW OUR OWN VEGETABLES AND HAVE LIVE STOCK AND CHICKENS WHICH PROVIDES US FOOD. ALSO IVE RESEARCHED THAT SOLAR FARMS CAN CAUSE SERIOUS FLOODING ISSUES. OUR ROAD ALREADY HAS ISSUES NOW! THE BRIDGE BELOW OUR HOUSE HAS BEEN DEEMED UNPASSABLE FOR THE SCHOOL BUS TO DRIVE OVER. I WORRY ABOUT THE SOLAR FARM EQUIPMENT DAMAGING IT FURTHER. ALSO, I VISITED THE SOLAR FARM IN SUMMERSHADE. THE NEIGHBORS COMPLAINED OF HOW HOT IT IS ALL THE TIME, WHICH POSES SERIOUS CONCERN FOR FIRES. I DON'T THINK OUR LOVCAL FIRE DEPARTMENTS COULD HANDLE A LARGE SOLAR FIRE. ALSO THE COMPANY HAD ONLY MOWED IT ONCE THIS YEAR. JOHNSON GRASS WAS GROWN UP ALL AROUND IT AND THE TREES THE COMPANY SAYS THEY WILL PLANT WHERE SPARCE, JUST 1 EVERY 100 FEET APART, NOT A SCREEN AT ALL. THE EMF FROM THE SUBSTATION WAS READING VERY HIGH. I DONT WANT THIS AROUND MY FAMILY. IT ISNT SAFE. EMF EXPOSURE CAN CAUSE CANCER AND LOTS OF SIDE EFFECTS. AND CADMIUM WHICH LEECHES FROM THE PANELS IS A KNOWN CARCINIGEN AND HIGHLY TOXIC WHEN YOU'RE EXPOSED. ALSO THERE ARE PHALATES EXPOSURE WHICH ARE KNOWN HORMONE DISRUPTORS. PLEASE DO NOT APPROVE THIS PROJECT FOR THE SAFETY OF MY FAMILY AND MY NEIGHBORS. EXIE SOLAR IS ASKING FOR A DISTANCE OF 200 FEET FROM MY RESIDENCE, NOT MY PROPERTY LINE. THAT MEANS THE COMPANY WILL PUT THESE PANELS DIRECTLY ON MY PROPERTY LINE. THE STATE REQUIREMENTS SAYS 1642 FEET IS FOR SAFE EXPOSURE. THIS COMPANY OBVIOUSLY ISN'T LOOKING FOR THE SAFETY OF THE

SURROUNDING PEOPLE THAT LIVE NEAR THIS FARM. I AM EXTREMELY UPSET THAT THEY USED MY ADDRESS FOR EXIE SOLAR FARM. I HOPE YOU WILL CONSIDER THE DANGER AND UPROOTING THAT THIS SOLAR FARM PROJECT WILL CAUSE TO MANY PEOPLE AND FAMILIES. THANK YOU FOR YOUR TIME, TABITHA ERVIN
