Comments:

I am opposed to the proposed rate increase requested by KY Power because the increase appears to be driven only to increase profits and not to benefit the public. According to its latest filing (https://docs.aep.com/docs/investors/Filings/docs/2025subsidiaries/2Q25-KPCo.pdf) the company reported profits of \$17.6M for the first half of 2025, which is a nearly 58% increase from the same period of 2024 (profits were \$11.1M). Its parent company, AEP, also reported significant profit gains compared to the same period in 2024. Overall, the financial filings show that KY Power and AEP are healthy, profitable companies. The request to increase rates appears to be driven solely to increase profitability and shareholder dividend payments at the expense of the public. This is further complicated by the fact that KY Power has a monopoly in most of its service area (including mine) which means that customers have no choice but to pay whatever KY Power is charging and cannot benefit from free market competition.
