Dear Kentucky Power Leadership,

I'm writing from Ashland, Kentucky as a customer, parent, and neighbor who's terrified of what another double-digit rate increase will do to families here.

You have announced a new base-rate request that would raise residential bills by 14.9%. That comes on the heels of the 5.66% increase approved in January 2024 and the 6.37% securitization surcharge added in July 2025. If this latest request is approved, the cumulative impact since early 2024 would push typical bills roughly 29% higher than before—an increase our community simply cannot withstand.

This isn't an abstract policy discussion. My household has seen bills hit \$400 on "budget billing". Many neighbors are getting monthly amounts they cannot afford even on the budget. In Ashland, the median household income is just \$52,199, and about 23% of residents live below the poverty line. A \$400+ electric bill alone consumes ~9% of the median household's monthly gross income. Energy experts consider 6% of income a "high" energy burden and 10%+ "severe." We are already there—or dangerously close—before your proposed hike lands.

Kentucky's electric system is a regulated monopoly. We do not have retail choice. We cannot pick a different provider if prices become punishing. With that monopoly privilege comes a duty of care to the people you serve. Piling on another double-digit increase after two sizable hikes in two years feels less like "keeping the lights on" and more like exploiting the lack of alternatives in one of the most economically fragile regions of the state.

Reliable power is essential. But essential does not mean exploitative. When a regulated monopoly repeatedly seeks large hikes from a region with low incomes and high poverty, it breaks trust. Please do the right thing: pull back this request and bring forward a plan that lowers bills through efficiency and targeted help—not through ever-higher charges.

# Re: Public Comment on Kentucky Power's Proposed 14.9% Rate Increase

#### To the Members of the Commission:

I am writing to express my strong opposition to Kentucky Power's proposed 14.9% residential rate hike. Families and communities in Eastern Kentucky are already carrying one of the heaviest energy burdens in the state, with Kentucky Power customers paying the highest average residential bills in Kentucky. This proposal would only make that hardship worse.

Kentucky Power has attempted to justify these increases by pointing to services they already provide, while also citing "loss of load" due to reduced customer usage. In reality, ratepayers have worked hard over the past decade to reduce energy consumption. Rather than rewarding efficiency and conservation, Kentucky Power is penalizing customers for it.

The company reported a profit of \$13.7858 billion in 2024, an increase of 11.13% from the prior year. It is deeply unfair for a corporation earning record profits to demand further sacrifices from the very people who can least afford it.

This increase also comes on the heels of multiple prior hikes. Customers are still paying for the **6.37% increase tied to the 2016 retirement of the Big Sandy coal plant**, which resulted in the loss of good-paying jobs and critical local services. Additional increases in **2021 and 2023** have already strained households beyond reason.

The proposed 14.9% hike far outpaces inflation. If approved, it would **double the rate of inflation since 2010**. Many Kentuckians already spend as much as **12% of their monthly income on power bills**. For those families, this proposal would mean impossible choices between keeping the lights on, paying for food, or affording medical care. Simply put, we cannot afford it.

The Public Service Commission has a duty to protect consumers from unjust and unreasonable utility practices. I ask: will the PSC do what is right for the residents of Eastern Kentucky, or will struggling families once again be left out in the cold?

It seems as if every time I send an email to comment on AEP's request for a rate increase they ask for another almost immediately. I can quote facts. But I believe real world experience often holds more weight. Thus I'll share my own.

As I went through my AEP records I discovered in Aug. 2024 my average temp was the same as Aug. 2025 (78 degrees). As you can see my temp was kept quite high. But the difference was my bill was \$74.09 more. May I also add all but two lights are LED. They

are CFL 15 watts. I have a small 2 bedroom house.

My 94 yr. old widowed neighbor has a similar size house. The only light she keeps on is in the room she's in. We all warn her how dangerous that is at her age. But she can barely afford her electric bill now.

When the current federal budget passed there was already a deduction in heating assistance. So much so that it ran out of money almost 2 weeks early. I've had several friends tell me if not for LiHeap they would have been made homeless because they just didn't have that much money.

Please consider these real experiences along with cold facts. There is no reason anyone should get sick or die from heat or cold. If counties only a fraction of our size (smaller or larger) can profit on less there is no excuse Kentucky Power needs more.
