

To Whom It May Concern:

We have been citizens of eastern Kentucky practically all our lives and we love our state! But we NEED an intervention by someone who can protect the interests of those in our beautiful state who are going to be affected by the reckless business practices of American Electric Power/Kentucky Power. We will use the company names interchangeably.

Knowing that the Public Service Commission members have changed over the years, we would like to give you a brief history of what American Electric Power has done to our area in Kentucky. Around 2013, Kentucky Power had a public hearing in Louisa, Kentucky, regarding the shutting down of our coal-fired power plant. I, Jeff Kinser, was in attendance at this meeting. Kentucky Power proceeded to tell the rate payers in this hearing that we had two options: One, if they put scrubbers on the power plant, our rates would increase by 30 percent; Two, that if the rate payers of Kentucky would buy half of the Mitchell plant, which is located in West Virginia, our rates would only increase by 12 percent.

The Public Service Commission allowed Kentucky Power to go with the second option, acquiring the Mitchell Plant. After 2015, when they tore down the plant and implemented these changes, that rate increase and the riders that were put on the bills well exceeded 30 percent. Since that time, American Electric Power has had another rate increase and also changed the tariffs on commercial businesses and public utilities, putting demand charges

on their bills. This has drastically increased the amount of electricity charges in our area.

In reading the request for the rate increase, Kentucky Power said it was due to business and population decline in eastern Kentucky. Part of the reason businesses are leaving our area, especially where Kentucky Power is their provider, is the price being paid for electricity. It is exorbitant.

And nowhere over the years of them requesting these rate increases, have they said they were downsizing their staff, streamlining their business or decreasing dividends to their stockholders. Kentucky Power is a publicly held company, and the Public Service Commission should take a hard look at the amount of the dividends disbursed to their stockholders and the salaries of the executive branch officers.

We support people working for a living and making a good living. But when exorbitant salaries are placed on the backs of working people, with some struggling to keep the lights on, that's when INTERVENTION needs to happen. We know people personally that are in that very situation; this is a FACT.

I, Jeff Kinser, am also a current sitting member of the Louisa Water and Sewer Board. I do not know if the Public Service Commission has considered that when Kentucky Power gets a rate increase, public utilities' electric rates rise as well. Therefore, usually public utilities must raise the water and sewer rates. This means not only is the public forced to pay a higher electric bill, but they also face higher water and sewer charges. The public utilities cannot absorb the rate of the increase. At the present time, the electricity rates being paid by our water and sewer are crippling the utility company. I am sure we are not the only utility company suffering from high electricity rates.

I have served on the Water and Sewer Board for several years. To give you an idea of these rates, approximately eight years ago, our normal electric bill for our utility company ran from \$21,000 to \$23,000 a month. Our July bill for this year was around \$44,000 and this is after several years of modernizing and automating our plant to become as efficient as possible.

Additionally, I have been a small business owner since 1992 in this area. In those years, we have had to run our business efficiently and streamline it to survive. We do not have the luxury of mismanaging our business funds. We cannot just go and ask for more money. If Kentucky Power was a private business, it would not survive, at least not how it operates its business at this time. The best outcome that the ratepayers of Kentucky could ask for

would be that the electrical grid in the state of Kentucky be deregulated and opened up for competition.

Competition is a good thing in business. Deregulation would give you a well-run company that would strive to give a good service in order to gain customers. The rates would be lowered to achieve this goal. At the current time, the electricity rates dissuade business from locating in eastern Kentucky. We need new businesses to locate here in eastern Kentucky to replace the lost coal mining jobs. If you notice, the large-scale job announcements are going south to states with better electrical rates or states where utilities have been deregulated.

We hope when you read this that you truly consider from your heart what is the best for the people of eastern Kentucky.

Dear Kentucky Public Service Commission,

My name is Alvin Blanton, and I reside at Catlettsburg, KY in Boyd County. I am writing to express my deep concern and strong opposition to the proposed 14.9% rate increase by Kentucky Power in Case No. 2025-00257. This rate hike is not reasonable, and it is certainly not sustainable. Since 2010, our electric bills have risen at nearly twice the rate of inflation. If approved, this increase will push our costs even further beyond what working families and retirees can bear. It will be devastating to our region.

Kentucky Power has repeatedly cited population decline as justification for raising rates. Yet out of the 20 counties they serve, 19 are projected to lose significant population by 2050—according to the University of Kentucky's projections. These numbers are public, widely available, and should be central to any responsible business planning:

- Breathitt: -51% - Floyd: -44.4% - Clay: -41.6%

- Carter: -32.5%

Martin: -33%Pike: -26.3%Knott: -25.6%Perry: -22%Greenup: -21.1%

- Leslie: -29.5% - And many more...

Only Rowan County is projected to grow (+18.5%). Boyd County, where I live, is projected to decline by 8.7%—but I believe that can be reversed with smart investment and community support.

Kentucky Power must right-size its business model to reflect these realities. You cannot continue to raise rates on a shrinking customer base and expect economic recovery. This trajectory punishes those who remain, and it undermines the future of Eastern Kentucky.

I urge the Commission to reject this rate increase and demand a more responsible, community-minded approach from Kentucky Power. Our region deserves better.
