I find it very difficult to pay huge electricity bills to Kentucky Power Company. At this time, I am splitting my monthly power bills into 2 payments. My power bills have become outrageous. I am not personally getting an increase in my bi-weekly paycheck. I do not understand how the PSC and Kentucky Power expect the average (fixed income and working poor) working person to pay these ridiculous power bills. There is no competition, so the rates continue to climb. Kentucky Power makes regular fuel adjustments and has just added a securitization surcharge with approval from the PSC and Kentucky General Assembly. Kentucky Power has increased the rate twice within the past five years following approval from the PSC (see below):

- 1) PSC approved an increase in January 2024 of 5.66% (based on internet)
- 2) PSC approved an increase in 2021 of 15.46% (based on internet)

Many in my area will have to decide whether or not to buy food, medicine or pay their power bill. We are all at the mercy of the PSC. Please do not approve the 15% increase now or in future. As a business Kentucky Power should not be able to pass on all costs of doing business to their customers.

Dear Kentucky Public Service Commission,

My name is James Marcum, and I reside at Catlettsburg, KY in Boyd County. I am writing to express my deep concern and strong opposition to the proposed 14.9% rate increase by Kentucky Power in Case No. 2025-00257.

This rate hike is not reasonable, and it is certainly not sustainable. Since 2010, our electric bills have risen at nearly twice the rate of inflation. If approved, this increase will push our costs even further beyond what working families and retirees can bear. It will be devastating to our region.

Kentucky Power has repeatedly cited population decline as justification for raising rates. Yet out of the 20 counties they serve, 19 are projected to lose significant population by 2050—according to the University of Kentucky's projections. These numbers are public, widely available, and should be central to any responsible business planning:

- Breathitt: -51%

- Floyd: -44.4%

- Clay: -41.6% - Carter: -32.5% - Martin: -33% - Pike: -26.3% - Knott: -25.6% - Perry: -22%

- Greenup: -21.1% - Leslie: -29.5% - And many more...

Only Rowan County is projected to grow (+18.5%). Boyd County, where I live, is projected to decline by 8.7%—but I believe that can be reversed with smart investment and community support.

Kentucky Power must right-size its business model to reflect these realities. You cannot continue to raise rates on a shrinking customer base and expect economic recovery. This trajectory punishes those who remain, and it undermines the future of Eastern Kentucky.

I urge the Commission to reject this rate increase and demand a more responsible, community-minded approach from Kentucky Power. Our region deserves better.

Dear Kentucky Public Service Commission,

My name is Bryan Benedetti, and I am a resident of Pikeville in Pike County, Kentucky. I am writing to express my strong opposition to the proposed 14.9% rate increase for residential customers filed by Kentucky Power (AEP).

Electricity is a basic necessity, and this significant rate hike would place an unfair burden on households already struggling with rising costs for housing, food, and healthcare. Eastern Kentucky has faced repeated natural disasters, economic challenges, and population decline—now is not the time to increase utility costs on hardworking families.

My power bill has already doubled since I moved to Kentucky three years ago, from around \$250 per month to just over \$500 per month. Another rate hike of any kind, especially one as drastic as 14.9% is unacceptable and untenable. With my Bachelor's degree, my current bill without the hike is 25% of my income. Once I complete my Master's degree, it will be around 12% (which percentage would be lower if I worked anywhere besides Eastern Kentucky). My wife, with a doctorate, is paying 8% of her take-home pay currently without a hike. Furthermore, if I did not have at least a bachelor's degree (which is about 73% of Kentuckians, and even more when focused on Eastern Kentucky), my current power bill would be 100% of my take-home income. (I

know because I work as a case manager with many people without a degree, helping them find employment or further their education). Any rate hike is economic suicide for Kentucky. Finding other solutions is absolutely imperative.

I also happen to know that public housing in many of Kentucky's counties is on a two-year waiting list. This speaks to a much broader economic and social issue. Taxpayers are subsidizing housing for so many Kentuckians. With rate hikes, this calls for even more subsidies from the taxpayer, which they cannot afford to give. This will lead to an even higher rate of homelessness, drug addiction, crime, imprisonment, and overall cost for Kentucky, which it cannot afford.

Kentucky Power customers have already seen multiple rate increases in recent years. Passing on the costs of infrastructure projects, storm recovery, and corporate decisions to already overburdened ratepayers is unjust. AEP, as a profitable parent company, should be expected to absorb more of these costs rather than shifting them entirely to consumers.

I urge the Commission to deny this proposed rate increase and to ensure that utility rates remain fair, affordable, and equitable for all Kentuckians. Rates need to be lower, not higher. Otherwise, Kentuckians need much higher wages, lower prices on commodities, and reduced inflation on the dollar. Please protect residential customers and prioritize economic stability in our region.

Hello, My name is Kayla Tackett, and I am a concerned citizen in Knott County, Kentucky, who grew up here and am now attempting to raise a family here which is seeming to be impossible. As a daughter and granddaughter of coal miners who worked to mine the coal for electricity, I feel that we are being punished for living in eastern Kentucky. My husband and I are both nurses working to provide a living for our family of two children, and the price for our electricity is astonishing. For the last 3 months, I have paid an electricity bill of \$400. We live in a one story home less than 2000 square feet where we have had our home evaluated for savings on

electricity. We strive to decrease our electricity usage monthly. The fees that continue to be approved for Kentucky Power is ridiculous. I am an educated individual who understands that prices have increased but when we look around and see no one paying the bill prices we are, I am sickened. I requested Kentucky Power come to check my meter to determine if the usage was correct. I was told today by an individual from Kentucky Power that there would be a \$50 charge for them to drive to my home and run a test on the meter! \$50?!? After I have already paid \$1200 in the last just 3 months to them for electricity. AND., they are requesting higher rates on the power. If this continues to get approved, I'm not sure how eastern Kentucky will survive. In comparison when reviewing the increases you have allowed, last August I used 100 MORE kilowatts and my bill was \$100 more this August. That is RIDICULOUS! If you want people to move out of eastern Kentucky, just buy our homes and allow us to move, but this must be stopped. This is robbery and abandonment from our elected officials. I feel at this point a law suit should be initiated against Kentucky Power due to the corruption against eastern Kentucky. As a nurse working to provide care in eastern Kentucky, I will never see any type of retirement other than the one I've worked on for myself, but Kentucky Power will be basking in theirs as we continue to pay astronomical bills to get terrible service. 
