Dear Kentucky Public Service Commission,

I am writing to formally oppose the proposed 14.9% rate hike for Kentucky Power customers in Case No. 2025-00257. As a resident of Kentucky, I am deeply concerned about the ongoing financial strain this would place on families and businesses already struggling to make ends meet.

Kentucky Power customers are already paying the highest average bills in the state, and this latest increase—on top of the recent 6.37% surcharge in July 2025—would push the average monthly bill to an unacceptable \$218 for typical usage. With the rising costs of groceries, fuel, housing, and everyday essentials crushing household budgets across the Commonwealth, another rate hike is simply not acceptable. Many of us are fixed-income seniors, working families, or small business owners who cannot absorb yet another burden without sacrificing basic needs.

The PSC has a responsibility to protect consumers from excessive utility costs, especially when Kentucky Power has a history of frequent increases (including the 5.6% hike in 2024 and 15.46% in 2020). I urge the Commission to reject this proposal in full or reduce it significantly to reflect the economic realities faced by ratepayers.

Rates must be fair, just, and reasonable. I urge the PSC to reject or greatly reduce this rate increase, and to protect low-income households and seniors on fixed incomes.
