Dear Commissioners,

I am writing to express my strong opposition to the proposed rate increase that Kentucky Power is trying to impose on their customers.

When will enough be enough?

Despite the fact that AEP (Kentucky Powers parent company) reported record profits in 2024 in the amount of \$3 billion, here they are once again, hat in hand, requesting yet another rate increase of 14.9%. I guess a profit of \$3 billion wasnt enough for someone, so now they want to squeeze out a little more. By the way, this is after the recent 6.37% "Securitized Surcharge" they already slapped on us over the summer, allegedly to recoup costs from the closing of the Big Sandy Coal Plant.

Further, in case I havent already made my point clear enough, a study from 2023 shows that Kentucky Power customers already have the highest average residential electricity bills in the state. And they decided that wasnt enough, so now they want more. How does that make any sense?

In my opinion this is pure greed, plain and simple. All that matters is maximizing shareholder value, while screwing over the rest of us.

Our area is already suffering from economic hardship, lack of opportunities, and ever-increasing costs that make it harder and harder just to survive. Breathitt County specifically is one of the poorest areas in the entire country, let alone the state of Kentucky. With a 2023 median household income of about \$19,155, approximately 30% of our population lives well below the poverty line. An additional 15% hike on an already outrageous to begin with electric bill could be the difference between being able to keep the lights on or putting food on the table for a family thats already struggling to get by. Of course, with \$3 billion in profit, this a decision that I suspect the executives of this company would never have to make. Nevertheless, its a
