I'm a father of Pike County, Ky, Among many of small children here just trying to make it.

We do the best with what we can because it's what we've always done. Most of us make do, in older run down homes, or small mobile homes all barely insulated and drafty.

Most of us, myself included, live on a disconnection notice, trying to keep up a bill a month behind, all while trying tk feed families, and our electric bills are always the highest bill of all.

Giving us smoke tests, and advice on how to be "more energy efficient" doesn't help a bit when we can scrape up the money to fix the problem. It's impossible to just up and have a home insulated, Replace windows and seals, Etc. when you can hardly afford the bill your already getting.

As well, it's tough for me to understand when our lowest usage bills are several hundreds more in our area, than towns down state with much higher incomes. Especially for our fixed and low income homes.

It's a terrible mistake to agree to a 15% raise on our community, considering most are already trying to figure out how to either feed their families or keep them warm. \$300+ is unreasonable for any home.... And most of us are battling 400-500, Some even 700. How can it even be possible for someone to use this much power.

The little people here are starving. While everything goes up in price and cost while the paychecks stay the same.

If equipment needs updated and changed, should fall on the company.

If a competitor were to come in here, things would be a lot different. We're foiled because of no competition. That's what this boils down to.

It's hard enough on us. stop allowing these increases. Unless the paychecks start being cut by the same percentage for their employees.
