I would ask you to NOT APPROVE a rate increase for Kentucky Power. Just Say NO!

As the Kentucky PSC your job is to consider the interest of the Public FIRST. The Kentucky PSC is suppose to determine fair, just, and reasonable utility rates—in this case electrical rates. Is it fair, just, and reasonable to grant Kentucky Power another rate increase when their 2025 annual profits exceeded \$36 million? Is it fair to grant them a subsequent year rate increase when their parent company AEP profits exceeded \$3.0 billion?
