My husband and I chose Ashland. We moved here in 2021 because we fell in love with the mountains, fresh air, elbow room, simple lifestyle and down-to-earth people. Both of us have lived in rural communities before—in California, Colorado, and Indiana. Of all the places we've lived, we like Appalachia best.

What we have learned about rural communities throughout the United States is that so many people have left the area to seek greener pastures, leaving the few who stay—usually with lower incomes—to cover the costs of public services. Lower populations mean fewer taxpayers/ratepayers to share the burden of public infrastructure, such as roads, electricity, water, sewer, and broadband.

Take Boyd County, Kentucky, where we live, for example. The Median Household Income (MHI) is \$60,659.00 annually/\$5,054.92 monthly. The average Kentucky Power customer uses 1,300 kilowatt hours (kWh) of electricity per month. The current rate is 14.5¢ per kWh, making the average monthly bill \$187.94. That makes up 3.72% of the median household income.

If Kentucky Power raises its rate 14.9% to 16.6¢ per kWh, the average monthly bill will rise to \$215.94, which is 4.27% MHI.

These are public services. The mission is not to make a profit. The mission is to provide a service to the community in the most effective and efficient way possible to the ratepayers.

Kentucky Power is an operating company within the American Electric Power (AEP) system. William J. Fehrman, CEO of Appalachian Power, receives nearly \$14 million a year in a cushy compensation package of base pay, bonuses, non-equity incentive compensation and stock options. Other high-ranking managers within the company have lucrative compensation packages as well. And we all know that compensation package is a shell for increasing wealth while avoiding taxes. The working-class ratepayers of Eastern Kentucky should not be subsidizing that gluttony.

The proposed rate increase should be denied.

To the Commissioners,

My name is Keith Watts, and I am a candidate for County Commissioner for District One in Boyd County, Kentucky. I am writing to formally and emphatically oppose Kentucky Power's proposed 14.9% rate increase.

As a local leader and someone directly accountable to the people of Eastern Kentucky, I must be clear: this increase is unacceptable given the current economic conditions facing our region. Eastern Kentucky already endures some of the highest poverty rates, lowest median household incomes, and greatest economic instability in the Commonwealth. A nearly 15% increase in electric rates is not merely an inconvenience — it is a direct threat to household stability, public health, and economic survival.

Electricity is a basic necessity. Many residents rely on it for heating, cooling, medical equipment, and food preservation. Seniors on fixed incomes, working families living paycheck to paycheck, and individuals with disabilities cannot absorb increases of this magnitude. For them, higher utility bills translate into impossible choices between power, food, medicine, and housing.

From a policy standpoint, Kentucky Power must not be permitted to shift the financial consequences of its long-term planning decisions, capital expenditures, or corporate restructuring onto captive ratepayers who have no alternative provider. The Public Service Commission's responsibility is to protect consumers, not guarantee profit margins at the expense of economically distressed communities.

Additionally, the proposed increase would place further strain on small businesses throughout Eastern Kentucky. Higher operating costs will lead to reduced employment, increased prices for consumers, or business closures — outcomes that directly undermine economic development efforts that counties like Boyd are actively pursuing.

As a candidate for County Commissioner, I am deeply concerned about the downstream impacts this rate increase would have on county governments as well. Increased utility costs affect county facilities, emergency services, and public infrastructure, further stretching already limited local budgets and ultimately shifting more burden back onto taxpayers.

I urge the Kentucky Public Service Commission to exercise its full authority to reject or substantially reduce this proposed increase. Any rate adjustment must be justified, equitable, and grounded in the economic realities of the communities served. Eastern Kentucky should not be expected to shoulder disproportionate financial hardship to offset corporate costs.

The people of Eastern Kentucky deserve fair treatment, transparency, and protection. I respectfully ask the Commission to stand with ratepayers and deny this request.

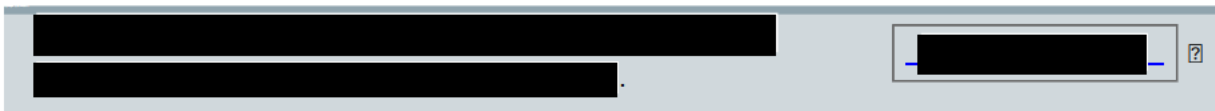

Commissioners,

I could not attend the public hearing on Thursday night, January 8, 2026, in Ashland, Kentucky, because I have been fighting the flu. But illness does not silence the truth, and it does not stop the bills. So I am putting this before you in writing — clearly, directly, and without softening the edges — because the stakes for thousands of Kentuckians could not be higher.

I am 86 years old. I built my home in 1970 with my own hands. Kentucky Power placed me on a \$37 monthly budget plan back then — their number, not mine. I trusted their system. I paid every month. I did everything a responsible customer is supposed to do.

Today, that same plan is \$343.30 a month.
That is a 830.5 percent increase.

In that same time, my pension has increased zero percent.

I worked 42 years at Armco Steel. I paid every bill, every month, through layoffs, recessions, and hard winters. I never imagined that after a lifetime of work, I would be fighting simply to keep the lights on in the home I built.

And I am not speaking only for myself.

I speak for widows and widowers whose Armco survivor pensions drop to about \$140 a month because their Social Security check offsets the pension. I speak for retirees like myself whose pensions are based on the wages we earned in the 1950s and 1960s, and in the years that followed — years when pay was modest, families were large, and every cent mattered. I speak for disabled neighbors and working families who are already stretched to the breaking point.

These people cannot stand at a microphone. They cannot travel to hearings. They asked me to carry their voices, and flu or no flu, I am keeping that promise.

This rate increase request follows years of decisions that placed the burden on the very people Kentucky Power now wants more money from:

- The costly Big Sandy Plant conversion
- Years of high fuel expenses

- Planning missteps
- Inefficient, overpriced fuel-purchasing practices

Independent experts hired by the Attorney General and industrial customers found nearly \$17 million in overcharges.

Refunds do not erase the strain.
Refunds do not rebuild trust.
Refunds do not justify asking struggling families to pay more.

Commissioners, I am asking you to do something that should not require courage — only conscience. Picture someone you love: a parent, a grandparent, an aunt or uncle. Picture them living on a fixed income. Then imagine looking them in the eye and telling them their electric bill is going up again, even though their income is not.

If you could not say that to your own family with a clear conscience, you should not say it to mine.

People like us — steelworkers, miners, railroad workers, teachers, nurses — built the economy that Kentucky Power depends on. We kept the lights on in this state for generations. We paid every bill, every month, even when it hurt.

All we are asking now is simple:
Do not turn the lights off on the people who kept them on for you.

Because when a family can't afford electricity, something far more important goes dark.

And what goes dark is dignity.

I hope you will remember the people behind the meters — the people who built this region, who powered its industries, who raised their families here, and who deserve better than to be asked to pay for mistakes they did not make.

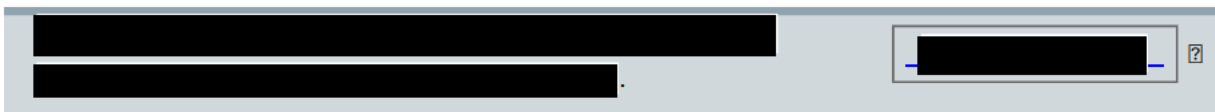

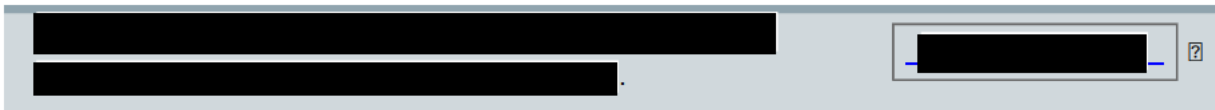

Dear PSC:

There is no way most of those in Boyd Co. can afford another increase in electricity. A vast majority are living on minimum wage. There is also a large amount of elderly that can barely afford their utilities now.

My home is 60x20 ft with a 10x10 shed. It's only one story tall and all but the fan on my front porch is LED lights. I get help from THAW and LiHeap as well as having it done on a monthly average. Yet my monthly bill is still \$215. a month. If your electric meter is removed your house is condemned by code enforcement.

A friend of mine finally got an apt. & her daughter back 3 months ago after being homeless since April of 2025. She's a waitress but her hours have been cut this month because of the economy. They gave her a week to come up with the money to pay the bill. So she's hoping to raise it through a GoFundMe page.

If you look on Ashland People Helping People and EKY Mutual Aid the most common request is for help with an electric bill. People shouldn't have to choose between paying a utility bill or being homeless because of bad choices utility companies made.

With LiHeap being reduced or discontinued it will be much worse. So please consider the poor, elderly & children that will suffer so AEP can get a higher profit for their stockholders.

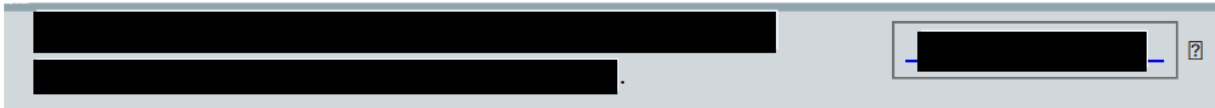

As a longtime resident and Kentucky Power customer from Inez, Kentucky I am writing to oppose the rate increase proposed by Kentucky Power. The PSC has already allowed this company 2 rate increases within the past 5 years in one of the poorest areas in the nation.

Their claim of not making enough profit because of population loss in this area is as rich in irony as their parent company, AEP, is in stocks. AEP posted a billion-dollar profit in just the last quarter of 2025. While Kentucky Power says it needs a rate increase because of the declining population in Eastern Kentucky I want the PSC to consider two things.

First, the people in this area cannot choose another source of power. That lack of competition has led to a lack of will on the company's part to work toward solutions that would benefit the region and the company's ability to maintain and run the system more efficiently. I don't know a whole lot about how an energy company runs, so I can't give many examples how they might work more efficiently, but I can assure you they have not done enough to keep trees cut from power lines during the part of the year when it would be easiest to do so. This must lead to increase costs through overtime pay during times of snow and ice, as those who have sat in the dark for days and weeks at a time can attest. I'm sure there are other areas we are not aware of where they could cut costs.

Second, the 20 counties under this subsidiary's control are some of the most distressed in the nation and raising the rates will have a disproportionate effect on many of their customers compared to the customers within the wealthier communities from which their parent company profits.

Also, this is an area where you should consider how a profitable company distributes its monetary weight. Why is it OK to increase prices in Eastern Kentucky for a loss in West Virginia at the Mitchell Power Plant but not acceptable to distribute the gains from the abundance across this multi-state, multi-billion-dollar corporation.

But the 'reverse Robin Hood' doesn't stop there.

The most insidious part of the plan is their proposal to charge more for those who use less energy, under the auspices of helping those who have higher bills due to the need for household weatherization. If, in fact, the company is aware of the need for help for those people, I propose they put more efforts into helping those folks. The plant wouldn't have to produce as much energy and the company could conserve money and prevent environmental degradation.

It should be obvious that this unbalanced difference in rates will be a boon to the wealthiest businesses, data centers, crypto-currency hacks, and those individuals who can afford huge homes that suck up energy at the expense of those who are trying to conserve either to save the planet or to save on their monthly bills. Either way it is an unfair expense and should not be allowed.

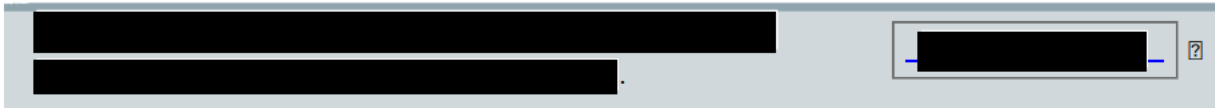

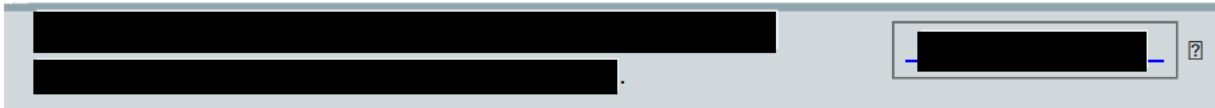

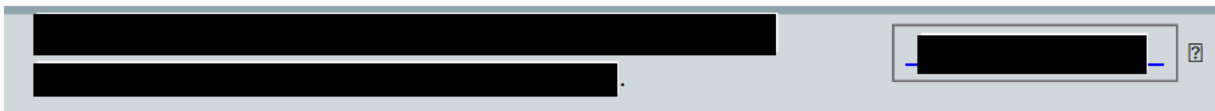

Dear Kentucky Public Service Commission,

Please accept this written public comment for inclusion in the official record for Case No. 2025-00257, regarding Kentucky Power's request for a 14.9 percent rate increase.

My name is Stephanie Dunaway, and I live in Ashland, Kentucky.

I am submitting this statement because Kentucky Power is requesting a 14.9 percent rate increase in a region that already pays the highest electric rates in the state and is also among the poorest areas of Kentucky.

This increase is not a minor adjustment. For many people in Ashland and throughout eastern Kentucky—especially seniors, disabled residents, and

families living on fixed or modest incomes—this represents a serious financial hardship. Electricity is not optional where we live. It is necessary for heating our homes, powering medical equipment, and maintaining basic living conditions.

Kentucky Power is owned by American Electric Power, a large investor-owned utility. According to American Electric Power's publicly filed 2024 financial statements with the U.S. Securities and Exchange Commission, the company reported approximately \$2.97 billion in net profit on nearly \$19.7 billion in revenue. This represents roughly a 34 percent increase in profit compared with the prior year.

It is difficult to justify asking the poorest region of the state to absorb a double-digit rate increase while the parent company reports nearly three billion dollars in annual profit.

In addition, the federal corporate income tax rate was permanently reduced from 35 percent to 21 percent under current law. This significant and lasting reduction in corporate tax liability has increased after-tax earnings for large corporations, including investor-owned utilities. Higher corporate profits resulting from this tax change reduce the need to raise rates on customers, particularly in economically distressed communities.

Household budgets in Ashland and across eastern Kentucky are already stretched thin. Food prices, insurance costs, housing expenses, and medical costs have all increased. There is no flexibility left. Utility bills are not discretionary, and there is nothing left to cut.

I respectfully ask the Public Service Commission to reject or significantly reduce this proposed increase. At a minimum, I urge you to require meaningful protections for low-income and rural customers, consider phased or alternative approaches, and carefully scrutinize corporate spending before approving any additional burden on Kentucky Power

customers.

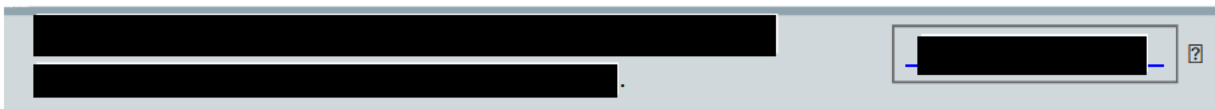

To the Commissioners of the Kentucky PSC:

We are writing to formally submit our dissent regarding the proposed general rate increase requested by Kentucky Power in Case No. 2025-00257. As residents of North Eastern Kentucky, we urge the Commission to deny this request in its entirety to protect a region already nearing a breaking point.

1. Unattainable Financial Burden

The proposed rate hike is not merely a clinical adjustment of figures; it represents a

direct threat to the health and safety of Eastern Kentuckians. Many residents are currently reporting utility bills that rival or exceed their housing costs. For those on fixed incomes, this increase forces a "heat or eat" dilemma—a choice between basic utilities and essential food or medicine.

2. Disproportionate Regional Impact

Eastern Kentucky faces unique economic challenges, including higher poverty rates and lower median household incomes compared to the rest of the Commonwealth.

Approving this increase ignores the reality of the region's declining population and shrinking industrial base. Shifting the burden of Kentucky Power's infrastructure costs onto a diminishing and financially strained customer base is unsustainable and predatory.

3. Rejection of "Business as Usual"

Kentucky Power has repeatedly sought relief through rate hikes, yet the quality of life for its captive customers continues to decline. The region's historical contributions to the energy sector, specifically through the coal industry, have left the landscape burdened and the economy fragile. It is unjust to demand further sacrifices from a population that has already given the most.

4. Call for Rigorous Scrutiny

I echo the calls from the Kentucky Attorney General's Office for the PSC to perform an exhaustive audit of Kentucky Power's financial practices. The Commission must investigate:

- Internal operational efficiencies (or lack thereof).
- The fairness of the proposed Return on Equity (ROE).
- Whether the company has truly exhausted all other avenues for cost-saving before turning to the pockets of the poor.

The PSC exists to ensure that rates are just and reasonable. There is nothing just or reasonable about a rate structure that pillages an economically distressed region to satisfy corporate margins. We respectfully request that the Commission prioritize the survival of Kentucky citizens over the profit requirements of Kentucky Power.

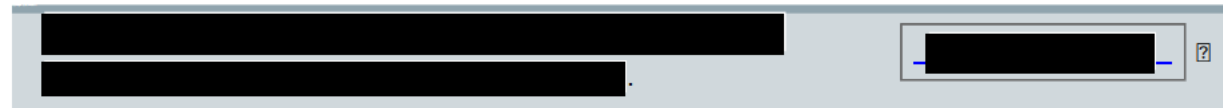

I work a full time job, Monday through Friday, and my husband works more than a full time job 7p-7a, Monday through Saturday. We have 2 small children who attend the local school. We have consistently over the last 9 months provided food to individuals in need. We have delivered food to people's homes, to the school to send home with students, and to local blessings boxes/food banks. Our community is struggling already. I fear with the increase in rates, my community members are going to lose their lives. People are being forced to choose between paying their mortgage or paying their electric bill. Paying for food or paying for electric. Paying for their monthly medications that keep them alive or their electric. KPC has a monopoly on the utility in our area. People have no choice. There's a vast difference between AEP and KPC's annual profits and what consumers are able to save each year. 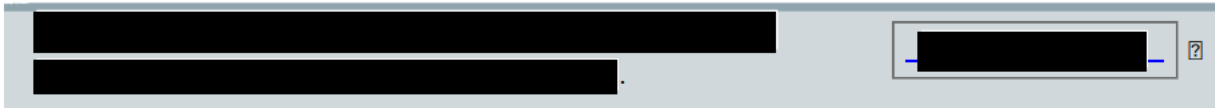

Dear Commission:

My comments made January 8, 2026 in Ashland, KY at the Public Hearing:

Members of the Commission, thank you for letting me speak today.

Like any household or business, running a utility costs money. No one disputes that. But when a company keeps coming back every few years asking for a large rate hike—already expecting it will be cut but still approved—that is no longer necessity. That is strategy. And strategies like that work only when someone else keeps paying the price.

Kentucky Power is not in danger.

The people it serves are.

Here's what that looks like in plain, hard-truth terms—and why people feel like they're running in place while falling behind.

In 2026, Social Security gave people a 2.8% cost-of-living increase.

But at the same time:

- Medicare Part B premiums increased nearly 10%, to \$202.90
- The Part B deductible increased over 10%, to \$283 a year
- The Part A deductible rose 3.58%, to \$1,736 per benefit period
- The APTC help with the Affordable Care Act premium disappeared for many working people and early retirees
- Insurance premiums rose as much as 27%

People are not keeping up.

They are falling behind.

This isn't because people aren't working hard enough. It's because more risk and more cost keep getting shifted onto individuals—especially seniors and people with disabilities—while working families are squeezed from both sides: too well off to qualify for help, and too poor to absorb another hit.

We are not moving forward.

We are going backward.

People are already going without health insurance. And if this Kentucky

Power rate hike is approved, many will also go without lights and heat.

Kentucky Power is allowed an authorized return—but that is not a guarantee.

It is a limit, not a promise.

A rate increase is a request, not a right.

This Commission does not exist to make sure a company always hits its profit target. It exists to protect the public from monopoly power while allowing utilities to recover reasonable costs. Sometimes, protecting the public means saying no.

Out in our communities, people don't get to pass costs along. When prices go up, they absorb them. They tighten their belts until there are no more holes left to pull. That is the reality outside this room.

This Commission exists to serve the public, not to guarantee profits. That's not rhetoric—that's your job. It's right there in your name: Public Service.

If you approve even part of this increase, the message is clear: ask big, ask often, and the people will make up the difference.

But if you deny it, you draw a line and say this stops here.

So today, I speak for the people who can't afford to be here—but who will pay every dollar of what you decide. I ask you to deny this rate hike in full, because someone has to speak for them—and today, that someone is me.
