Comments:

I am native to eastern Kentucky, and recently moved back after living in central Kentucky for 20 years.

Make no mistake: what's happening with electricity here is an atrocity. It is criminal.

My current electric bill is \$481 for a home with ~1,500 SF of living space. I was so shocked I could barely believe what I was seeing.

For context, I NEVER had a bill this high in seven years in Richmond in a house that was THREE TIMES THE SIZE.

The laundry list of fees is its own issue, but even when I boil this down to the electricity itself the comparison to living just 90 miles away from here is shocking. I was billed \$412.40 for 2,955 kWh of electricity, which translates to \$0.14 per kWh. In Richmond I paid about \$0.08-\$0.09. This is a ~55% increase in RATE.

How can that even be legal?

First, it shouldnt be. Thats abundantly clear.

Second, consider this blatant price gouging in historical and cultural context. Eastern Kentucky provided power to the country and other parts of the world for more than a century. The poverty the region bears witness to now is a direct result of the boom and BUST of the coal industry.

Please tell me how its fair or decent to now scalp outrageous amounts of money from people living in poverty in the same region. If anything, electricity should be subsidized considerably here as retribution for the continued economic and environmental devastation indirectly and directly caused by coal mining.

I think people are here so used to this kind of treatment that they are afraid to speak up or think it wont matter if we do.

But Im not.

I am working on my second doctorate, and I returned to eastern Kentucky to serve the region I love so much. And one way Ill do that is through relentless advocacy. I am fortunate enough to be able to afford this \$481 bill, and Ill pay it.

But hear me now: I do not take kindly to being robbed in broad daylight, and that is whats happening here.

A rate increase is absolutely laughable. You should be ashamed of whats already happening, and even more ashamed of asking to make it WORSE.
