I'm writing you today concerning the proposed rate adjustment requested by Kentucky Frontier Gas.

I am requesting you reject this proposed increase.

A 92% increase is too much and should not be allowed.

I have lived in Belfry, Ky since May 1981. First I was a Belfry Gas customer and my summer gas bill was on average \$7.50 a month. Then Kentucky Frontier Gas purchased Belfry Gas and our rates tripled.

I am enclosing my current gas bill. You will notice I used (1) cubic meter for a shortened month of 20 days.

Not sure why since they did not include a reason.

I used \$1.12 worth of gas and the other \$19 is what they are charging me for their business expense.

I am also enclosing my gas bill from the same billing period in 2024. Again notice I used (5) and that costs \$4.88 but I paid \$124.60.

In summer I only have a hot water heater - so that is a big change to heat water for 2 people. If the rate increase is allowed my bill will double. Please reject this request.
