We constantly had boil water advisories, and the water smelled very strong with a bleach smell. We were without water a lot. If the electric went off they didn't even have a generator to power the plant. I had a major surgery and was released from the hospital on a Sunday. The water was off and they didn't get it back till Friday. I went 5 days without a shower. At times the water was almost pure mud. It was very dark brown. We shouldn't have to live under those conditions. The water is so much better since we got Grayson water. And we haven't had to do without water. Please, please let Grayson County serve us!!
