Dear Kentucky Public Service Commission,

We are homeowners residing at 5626 Cutters Trace, Melbourne, Kentucky 41059.

On December 18, 2025, we received a letter from Bluegrass Water proposing a substantial increase in our monthly wastewater treatment rate. We are currently paying \$60 per month for wastewater service. The proposed new rate is \$114 per month, which represents an increase of approximately 90%. This rate increase far exceeds the percentage cited in the filing.

This proposed increase is extremely large and would place a significant financial burden on our household. We are concerned about the reasonableness and justification for such a dramatic rate hike and believe it warrants careful review.

We respectfully request that the Kentucky Public Service Commission intervene, review this proposed rate increase, and take appropriate action to ensure that any approved rates are fair, reasonable, and in the best interest of customers. Thank you for your time and attention to this matter. We appreciate the PSC's role in protecting utility customers across the Commonwealth.

I live in the Young Farm Estates subdivision which just had the sewage treatment plant bought last year by Bluegrass Water.

We are currently paying Bluegrass Water \$60 per month for wastewater treatment. They are advocating raising this to \$114 per month (a 90% increase).

The requested increase is unreasonable. If they couldn't maintain this plant at the \$60/month rate we were paying or something close to that, they should have disclosed that before the purchase went through instead of buying the plant and immediately asking for an unreasonable increase.


This correspondence is written to request total denial to the proposed rate increase by Bluegrass Water Utility Operating Company of 46.6% to residential customers. This huge rate increase presents a major burden to senior citizens and families.

Although I cannot speak to the upgrades and improvements that may or may not be necessary, I can speak to the unfairness to how the individual homes are billed. My opinion is that residences must be charged on the basis of water usage per home. Why should a home with 1 or 2 occupants pay the same monthly rate as a home with 4,6 or more occupants? Individual metering per residence could also be costly, but why can't residences be charged based on their individual water usage per month? I feel that billing a flat rate per home is outrageously unfair. Other utilities ie: electric, gas and water are not allowed to bill in that fashion. Therefore, why is Bluegrass Water allowed to bill at a flat rate.

Scott County is growing extremely fast and they, along with the State of Kentucky, should be involved in the cost of the necessary upgrades to infrastructure. I hope that you will consider my suggestion to basing the monthly sewer bills on individual usage and please do not burden the rate payers with a 46.6% rate increase.
