I received two letters from Bluegrass Water that they want to raise my current monthly water bills 36.7%. I have two properties that are served by Bluegrass in Calloway County. They both have water meters but they are never read by Bluegrass Water. We are billed a flat rate of \$77.63 per month. I believe this is a very high price based on the water used at my properties. In other properties in Calloway County,(outside of the City) served by the City of Murray the first 2000 gallons of water cost around \$23. I would be happy to pay for the water used, I just dont think it is fair to allow a flat fee to rise 37.7% . I know its costly to read meters every month, however they could read them every six months or once per year and make adjustments similar to how power companies do with budget billing.
