ORDER

On October 2, 2025, the Commission issued an Order requiring that "within 20 days of the date of service of this Order, Duke Energy Kentucky, Inc. shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariffs reflecting the changes to its base rates as a result of the roll-in of environmental surcharge amounts described herein." On October 22, 2025, Duke Energy Kentucky, Inc. (Duke Kentucky) filed a request for an extension for the filing of the compliance tariffs of one week, stating that its tariff in this case required it to file its tariff in Case No. 2024-00354, which was issued on the same day.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Duke Kentucky's October 22, 2025 motion should be granted.
